COVID-19 may have brought the world to its knees, but where it failed was in giving us a lesson in humility. A virus that should have brought us together and united us in our common vulnerability, ended up dividing us. The outbreak separated families, neighbourhoods, and cities. It re-erected forgotten borders; and when hope emerged through rapidly developed vaccines, it divided the world between those who had access to them and those that did not.

2022 saw us emerge from the pandemic, not to resume our journey into the future but to retrace steps to the cold calculations of distrustful empires at odds with one another. A new 'Iron Curtain' had resurrected itself across the heart of Europe. Great-power rivalry was back. The war in Ukraine will forever be a stark reminder of how our very connectedness could become our biggest vulnerability. Everything could be weaponised—the global financial system, supply chains, energy, food, fertiliser—all could be turned, at will, into weapons of mass destruction.

Our interdependence had become the chink in our armour. Our super-efficient, least-cost global value chains, our biggest risk. Our connections have to be severed, de-risked, no matter what the cost. And so we have arrived at an age where the common issues that afflict us threaten to divide us even more. Whether it be action to combat environmental degradation or climate change, or to avert another global financial crisis—the divide between the North and the South looks set to deepen.

In its post-pandemic form, this divide reflects much more than a disagreement over vaccines, climate action, or energy transition. The South today is genuinely worried about the lengths to which an unpredictable, insecure North can go as it responds to its own challenges. How much of a difficult, hard-won consensus on global affairs is it prepared to undo through non-consultative, punitive, and unilateral action? In short, the South is convinced neither by the capacity of the North



nor of the revisionist forces challenging it to become the arbiter, let alone the setter of norms that will define the coming international order.

Annus horribilis, 2022 may have been, yet in the maelstrom, if there was a glimmer of hope it was India's ascendance to the presidency of the G20. In a world divided into camps with the sole purpose of cancelling each other, the G20 today remains the only credible multilateral grouping that, for all its faults, can never be reduced to an echo chamber. A divided world better debate in a divided house than boast conformity in a gated commune.

Therefore, a lot has hinged upon India's performance during its G20 Presidency and will henceforth hinge on the unfolding of India's "*Amritkaal*"—the next 24 years that lead to the first centenary of its independence in 2047. The period matters not just for India but for the world, because a successful India can be the balm that heals the fractures that sunder the North and South. India's 'Vision@2047' seeks nothing less than a comprehensive transformation through rapid yet sustainable growth facilitated by new-age infrastructure and technology.

Vision@2047 also sets ORF's agenda for the "Kartavya kaal". During the first year itself, ORF stimulated expert discussions that culminated in the publication of over 2,000 short-forms and 200 long-form policy research papers. These included the report, Health Systems Resilience Index: A Sub-National Analysis of India's COVID-19 Response, written in collaboration with the London School of Economics. As part of the Amrit Mahotsav celebrations in August, ORF curated a compendium, 10 Policies Shaping a Sustainable India, that explored options to help shape a more sustainable future.

Such work would not have been possible without extensive collaborations with a diverse set of partners, in India and overseas, as we hosted our flagship forums such as the *Raisina Dialogue*, *Arabian Sea Dialogue*, and *CyFy*. A new initiative, *ORF SPARK*, was also seeded to mobilise young Indians around critical challenges facing the country and the world.

We revived the *India Think Tank Forum* for its fifth edition and convened the focus on G20 priorities during India's Presidency. In tandem with the G20 agenda, ORF fostered platforms such as the *Kigali Global Dialogue* and the *Climate Action Champions Network* to amplify the voices of the Global South. In all these forums, we made sure to shore up the diversity we knew was required for the most productive and insightful of convenings.

In the coming year, even as we consolidate and build upon the progress already achieved, ORF will continue to explore all paths that can aid us to reach the goals set for the centenary.

'Surreal' might be an overused adjective to describe an experience that does not seem real; but it is apt to use it for the world that greeted us as we emerged from the pandemic. It is a world that is, at one level, turning on itself. Where consensus eludes us and the fleeting sense of belonging to a larger community, briefly ignited during the battle against COVID-19, perished along with the end of the emergency. Where the world is a theatre and leadership an act; where amplifying ideological and intellectual divides has become lucrative. The respite courtesy the lockdowns is over, and the pre-pandemic landscape of dissent and contestations is now on hyperdrive.

Yet, beneath the clamour on social media, another reality endures—of the billions of people who see the future through a different gaze. Where, other than the 'cancel culture' and the Right-Left divides, genuine hopes and aspirations for a better tomorrow are valued more. And that remains the central poser for those who engage with issues of policy and governance: How do we invest our time and resources to serve that kind of tomorrow?

For India, 2023 has been a significant year. As we commenced our 24-year march to a century of independence, we also assumed leadership of the G20—a grouping of nations that are pivotal to the future, not for their economic size, but because their successes and failures have cascading consequences not only to their immediate regions but the whole world. Amidst conflicts and economic headwinds that refuse to die down, India stands out for its rejection of binary thinking and its steadfast focus on development issues that affect the underserved.

ORF's agenda is shaped by this deep Indian impulse and proposition. From reinforcing India's status as a global digital powerhouse to encouraging lifestyle changes to mitigate the climate crisis, ORF aims to align its research and ideas arenas with the country's goals. In the last year, we published two volumes that made true to this promise: *Aspirations, Access & Agency: Women Transforming Lives with Technology* and *Micro Matters*, both of which were joint publications with Reliance Foundation. The first told the stories of women leaders who have become change makers by embracing technology, and the second explored interventions by civil society organisations in



India that are advancing the country's drive to utilise data for development. We also published the report, *Climate, Community, Cooperation: An Indian Approach to Adaptation in the Global South*, a joint publication with PwC that assessed India's present approaches to disaster and climate risk management, adaptation, and resilience building. The volume sought to illustrate how India's successes and setbacks can give other countries lessons in fighting their own adaptation battles.

Also in the past year, ORF persevered with its enduring mission of connecting India to the world. In February, we launched *Raisina @ Sydney* alongside iterations of the Dialogue in Delhi, Berlin, and Washington, DC. The Raisina Dialogue is now truly following the sun, seeking inspiration from across the globe. We also planted the seed for what we intend to be a long-term investment in building the next generation of global diplomats. In October, we inaugurated the *Raisina Forum for the Future of Diplomacy* in New Delhi, bringing together diplomats from over 30 countries to rethink the spirit of their official responsibilities. We are very much aware that the investment in skills and character that may be demanded of these diplomatic emissaries has to be made now, and we hope to fill that need through this new annual initiative. Continuing our tradition of engaging the brightest minds from around the world, this year we welcomed the largest-ever cohort—comprising 48 fellows from 33 countries—of the *Raisina Young Fellows Programme*.

As the *Think20 Secretariat* under India's G20 Presidency, ORF strived to bring together think tanks and high-level experts to discuss policy issues relevant to the G20. Think20 India published over 300 policy briefs, nearly twice the number of policy briefs published by any other Presidency in the G20's history. The contributions were written by over 1,000 authors, from over 700 institutions, across 75 countries. Think20 under ORF also hosted over 60 events across India and in different parts of the world.

As we continue to engage with the issues that confront the world today, we remain steadfast in our commitment to addressing the lingering issues that seek sustainable solutions—among them, poverty and deprivation, and inequality. ORF will adopt a dual-track approach to navigate the twin challenges of creating pathways to 2047 and rectifying legacy shortcomings.

As we look ahead with renewed perspective, let me express my deepest gratitude to the members of our Board, led by our Chairman Mr Sunjoy Joshi, for their leadership and guidance; our indefatigable and talented Team ORF; and to our most valued partners and stakeholders for their effort, commitment, and support throughout this year. ORF is now a global platform, and we need to serve not just India, but all of humanity. As we face unprecedented crises of climate, geopolitics, and geoeconomics, we must remember, as perhaps we did during the pandemic, albeit fleetingly—that nothing can be fought nor won alone.

Three major shifts will play out rapidly during the 2020s: The transition from villages to cities; the transition to low-carbon modes of production and consumption; and the transition to an increasingly digital world. The effects of these will be felt by all economic actors: Business, markets, and finance, as well as workers, consumers, and communities. To attain India's goal of becoming a US\$ 10-trillion economy by the end of the decade, these shifts will have to be harnessed effectively. The Centre for Economy and Growth conducts research, produces commentary, and provides platforms along the following major verticals—Urban Futures, the Green Transition, Climate Finance, Energy and Resource Security, International Trade, Investment Policy, and New Multilateralism. Additionally, we have sought to provide a contextual understanding of the global discourse on climate action, particularly from the perspective of developing nations. Our aim has been to highlight the necessity for global partnerships to adapt and ensure equitable and inclusive transitions in these regions.

Furthermore, we have actively engaged with India's G20 presidency throughout the year, aiming to contribute valuable insights that can inform the G20's work on energy transitions and climate finance.



Vision for the future

Moving forward, the Centre for Economy and Growth is committed to furthering its efforts in understanding the interconnections between effective climate action and inclusive growth. Specifically, we will strive to delineate the parameters of a just and inclusive energy transition, placing emphasis on the pivotal role of facilitating increased investments in environmentally-friendly sectors that hold immense potential. Our focus will persist on promoting multilateral cooperation, implementing carbon pricing mechanisms, formulating green industrial policies, and encouraging private investment.

Furthermore, the Center will endeavour to expand its scope by identifying the necessary instruments, institutions, and incentives required to redirect capital towards building climate resilience in the most vulnerable communities within the developing world. Our ultimate goal is to shed light on the voices and regions that have thus far been marginalised in global policy discussions, thus, amplifying their significance.

Centre for New Economic Diplomacy

Mission statement

The mandate of the Centre for New Economic Diplomacy (CNED) is redefining economic diplomacy in a changing world. The majority of its initial interventions were in the domain of development partnerships and development diplomacy. With a plethora of disciplinary expertise in the domains of the developmental discourses, the Centre has now emerged to establish a fresh approach to post-pandemic recovery and resilience, aiming to forge new paths for development in the global south. To tackle the challenges faced by the global community, the Centre has actively sought to establish international partnerships and enhance multi-stakeholder responses. With a specific focus on regions such as South Asia, ASEAN, BIMSTEC, and Africa, where development challenges arise in different forms, including development deficits, environmental degradation, and social costs of growth, the Centre has concentrated its efforts in addressing those. Key areas of intervention for the Centre include India's development cooperation, technology, climate change, health, food security, technology and nutrition. Recognising the importance of gender equality in development, CNED has integrated gender as a crucial factor across its various initiatives.

A quick view of the past

The CNED scholars and the extended research community produced 93 long form papers and 268 short form pieces under the various focus areas of CNED research, along with 50 digital discussions and webinars. The Centre has conducted its last year's research in the domains of trilateral cooperation, green finance, issues of development and governance in the commonwealth, and more importantly, with the various concerns of the G20, given India's ongoing G20 Presidency. A first-of-its-type Climate Performance Index across the various G20 countries assessing the performance of the 20 nations in climate mitigation has been devised last year. Further even, one of the publications also delved into a comparative analysis of various nations' development cooperation models and argued how India's development partnership model stands out. On the other hand, CNED has also moved into the capacity-building space in partnership with the US Department of State through the creation of a network of climate champions. Two major convenings hosting and training more than 100 climate champions of South Asia were organised in Kathmandu, Nepal, and New Delhi.

The knowledge products involving the publications and convenings achieved last are envisaged to lay the foundations for the emergence of a new economic diplomacy for India and the global south. Through its various partnerships forged last year (for e.g., with FCDO, the Government of United Kingdom; Bill and Melinda Gates Foundation; AFD or the French Development Agency, etc.) and through various other endeavours, CNED has been able to expand its development network and community by engaging traditional and non-traditional stakeholders on issues that are critical to achieving the Sustainable Development Goals (SDGs) in its attempt to creating an inclusive, rules-based, and diverse global architecture.



Vision for the future

Given India's ongoing G20 presidency, the Centre plans to publish research papers and convene dialogues and panels on some of the potential priority areas of G20 and the T20, the official think tank engagement group of the G20. With ORF being the T20 Secretariat, CNED plays a pivotal role here. This will entail research and convenings in the domains of macroeconomic policy coherence, trade and livelihoods; digital technology, development and governance; LiFE and human well-being; green transition and green growth; global financial order; pathways towards SDGs; etc. Further even, the Centre plans to engage in critical analysis of the Regional Trade Agreements and Free Trade Agreements of India, the economic crises in South Asian nations, sustainable development finance in the Indo-Pacific, climate change and development priorities of the Global South, food and nutritional security, global health, amongst others.

Inclusive Growth and SDGs

Mission statement

How can we, as a generation, lead the way in eradicating extreme poverty, tackling the climate crisis, fostering a more equal society through promotion of distributive justice and promote human progress? How can we establish a resilient system capable of withstanding external and internal shocks caused by factors like climate change, global pandemics, and supply-chain disruptions? What are the economic, social and environmental consequences of our current development paths? Are there alternative paths to the conventional businessas-usual approach? The Inclusive Growth and SDGs programme is driven by these overarching questions. It aims to redefine the development paradigm by creating a comprehensive framework that evaluates the costs and benefits of various development paths, and understand the various existing trade-offs, to provide an objective basis for policy decisions. Through research and events, the program addresses complex issues at the intersection of the environment, development, society, economy, culture, health, and education. With a focus on equity and fair distribution, the programme strives to fulfil its mission of promoting inclusive growth.

A quick view of the past

This programme's activities have actively engaged with the broader framework of the critical interface of environment and development. Over the years, this entailed various domains of the blue economy, water governance and hydro politics, food and nutritional security, climate and development, human capital, and gender. Scholars have conducted research in diverse fields, publishing papers on topics like data for development, climate-resilient agriculture and the future of food, calorific definition of water productivity, climate adaptation in the Global South, policies shaping the future of sustainable India, the North-South divergences in SDG action, financial inclusion of women, women in politics, etc. Furthermore, the first of its type of Health Systems Resilience Index, evaluating the response to COVID-19 by each state and union territory in India, was released. Further even, the programme also conducted some country-specific analyses of economic crisis, especially in India's neighbourhood. Development financing has been a critical domain of last year's work.

Vision for the future

In 2023-24, there are plans to actively engage in projects on water governance in India, covering issues on national water policy, water and food and nutritional security nexus, water and gender, and water pricing and valuation. Further even, in association with the Reliance Foundation (RF), the Programme plans to carry out a survey to assess how the Foundation's interventions have led to changes in standards of livings of households. The Programme further intends to bring out a publication with RF and United Nations reviewing the replicable and innovative practices from India on the various SDGs. The long-term vision of this programme is to address the broader developmental challenges that emerge in the form of reconciling between the irreconcilable trinity of equity, efficiency, and sustainability. Therefore, the programme plans to conduct research on health and nutrition, blue economy, education, wealth and income inequalities in the emerging economies, development financing especially considering the SDG financing and climate adaptation financing, and natural resource accounting over the next two years.



Mission statement

In an environment of accelerating technological competition, the dynamics of international security and stability are intricately intertwined with the progress and potential setbacks offered by technological advancements. With its geographic and geopolitical position at the centre of the Indo-Pacific region, India finds itself at the precipice of this shift, grappling with the double-edged sword of shifting alliances and safeguarding its own economic growth, national security and prosperity of its people. As such, it is crucial to analyse and guide the collaborations India forges at this crucial juncture—with government and industry alike—and the balance its strikes between old partners and new.

The Centre for Security, Strategy, and Technology (CSST) endeavours to foster a robust platform for global discourse and the generation of innovative ideas regarding the profound impact of technology on national and international security, with specific relevance to India, the Indo-Pacific region, and the global order. By nurturing a diverse and engaged network of stakeholders, CSST aims to shape a collective understanding of our shared technological future, thus laying the foundation for a more secure, equitable and prosperous global order

A quick view of the past

During FY2021-22, CSST has sought to broaden its engagement through collaborations, interactions and partnerships, both in India and on a global scale. The Centre sought to foster debates on cutting edge technologies and platforms, like the metaverse, and decentralised platforms and technologies, quantum technologies, and space as well as foundational issues like AI governance, data protection, cybersecurity, supply chains and the impact of tech on democracy. CSST researchers also contributed to the Think20 engagement group as part of India's G20 presidency, particularly through the task force on Digital Public Infrastructure.

Vision for the future

In FY2023, CSST will delve into emerging tech threats, governance challenges and opportunities for India to forge collaborative partnerships. Some of these areas include Generative AI, Biotech, nuclear terrorism, semiconductor supply chains, and quantum technologies. Can older arms control frames animate discussions around emerging technologies or do we require new frameworks and conventions? How do we build greater tech literacy around all these areas amongst policymakers?

Upcoming projects include Track 1.5 dialogues and research outputs under the Quad Tech Network, the Critical Quantum Technology: Creating Scientific Fluency, Ethical Awareness and Policy Options for a Quantum Future project with the University of Sydney, developing areas of cooperation under the framework of the U.S.-India initiative on Critical and Emerging Technology (iCET), and the threats of nuclear terrorism in South Asia.



Strategic Studies Programme

Mission statement

ORF's Strategic Studies Programme seeks to shape India's foreign policy and national security choices by deepening understanding and identifying policy interventions on contemporary Indian and global debates. The programme offers an original analysis—a mix of theoretical, historical, and practical perspectives through extensive academic research, interdisciplinary studies, data-driven analysis, and engagement with experts and policymakers. The programme's outreach activities, in the form of seminars and roundtables as well as collaborations with ORF's growing network of worldwide partners and researchers, serve to enhance and frame the growing public debate, domestically and around the world, on India's power and its purpose.

A quick view of the past

In a world clouded with post-pandemic uncertainty and the sharpening of geopolitical contestation, the researchers of the Strategic Studies Programme continued to engage with a range of national and global stakeholders on key themes: The state of global (dis)order post-COVID-19; institutional infirmities and normative shifts; increasing great power contestation; the emergence of middle powers; evolving strategic contours in the Indo-Pacific, Eurasia, Middle East, and Africa; maritime challenges and opportunities in and around South Asia; trends in India's neighbourhood; India's economic integration and connectivity with key geographies; Indian foreign and national security policies; India's role in shaping multilateral institutions; public opinion and foreign policy, and the changing nature of warfare. The programme made important interventions in all the above-mentioned areas by producing academic research, policy studies as well as via extensive outreach engagements.

Vision for the future

Today, India is unmistakably global as it anchors itself as a regional and global stakeholder. A fragmented world and the advent of new challenges call for a contemporary understanding of power transitions, key geographies, global institutions, and security threats, critical to inform choices for an evolving and emergent India.

In 2023-24, the Strategic Studies Programme will continue to track regional and global developments and trends that implicate India's capacities and options, now and in the future.

Some key areas of focus include the following:

A continuing global power transition mandates greater scrutiny of the US-China rivalry and its impact on the Indian pursuit of its interests. Rediscovered geographies will likewise continue to be a key and expanding focus area, whether the broad Indo-Pacific and Eurasian spaces or sub-regions in India's immediate and extended neighbourhood. The programme will also delve into evolving traditional and non-traditional threats to India's national security amidst the changing nature of competition and warfare. The programme will recognise key areas for India to cooperate with like-minded countries to deal with emerging traditional and non-traditional challenges



As minilaterals continue to substitute old-fashioned multilateral organizations, the programme willrecognise and highlight new opportunities for India to enhance partnerships and reforms.

The programme will continue to keep a close track of India's diplomatic and political interactions, economic integration, and connectivity projects with key partners and geographies.

Our future research agenda aims to be forward-looking. India's role and responsibilities in the world will continue to derive from an understanding of the changes in the traditional global architecture as well as its own growing capacities.



25-26 JULY, 2022

US-INDIA TRACK 1.5 STRATEGIC DIALOGUE 2022

Description: ORF, in collaboration with the U.S. Naval Postgraduate School (NPS), held US-India Strategic Dialogue 2022, in New Delhi, India on 25-26 July 2022. This was the 13th iteration of an annual Track-1.5 project in which a small group of Indian and U.S. experts (both government and non-government) discussed a range of issues central to the U.S.-India relationship under Chatham House rules. Topics included the trajectory of the U.S.-India partnership, cooperation in the Indo-Pacific, Afghanistan, trade, and nuclear postures and cooperation.

Description: India and Brazil celebrated 74 years of diplomatic relations in 2022. In more recent years, the two countries elevated their relationship based on a common global vision, commitment to development and shared democratic values. They have had a strategic partnership since 2006, deepened in 2020 through the Action Plan to Strengthen the Strategic Partnership and are working together in various international forums, such as BRICS, IBSA, G4, G20, BASIC and the United Nations. The event discussed a report by ORF including three essays written by Indian authors and three others written by Brazilian authors. They revolved around the themes of the World Trade Organization, UN peacekeeping operations and UN Security Council reforms. It brings together scholars from India and Brazil to articulate new perspectives that could assist policymakers in both countries in identifying new opportunities for collaboration. 





Neighbourhood **Studies**

Mission statement

India's neighbourhood is in a churn. Old threats with the potential to disturb regional stability are reappearing in new ways even as new challenges are emerging that have serious implications for India's security. India's 'Neighbourhood First' policy needs new vigour to anticipate and accommodate the evolving scenario to harness the new opportunities that hold promise to transform the region. The Neighbourhood Studies initiative strives to analyse emerging trends in India's immediate neighbourhood and offer policy prescriptions that advance India's interests.

A quick view of the past

Over the past year, scholars of the Neighbourhood Studies programme organised events on developments in the region. They analysed these developments and their implications for India in their writings (both commentaries and long-forms) for ORF. The scholars associated with the programme were active in the print, electronic, and digital media offering their comments and analysis. There was active participation in events organised by other centres of ORF and interactions with scholars and officials who visited ORF.

Vision for the future

The Neighbourhood Studies Programme will remain focused on the economic, political, and security challenges in which the Indian subcontinent is embroiled. Even as Sri Lanka is slowly stabilising, there are serious political, security and economic challenges that threaten the stability of Pakistan, and by extension of India. The situation in Bangladesh remains fraught with an impending election amidst economic difficulties. Afghanistan under an unreconstructed Taliban poses a significant dilemma because of their potential to destabilise the entire region. Maldives is in flux. Nepal has a new government but continues to face old challenges of political instability and strategic contestation. The China factor is looming large over India's neighbourhood, not just in terms of the economic inroads it is making but also the political and security dimension that comes with this economic ingress. The Neighbourhood Studies programme aims to examine the impact of these developments on India's security and strategic environment and policies to mitigate them. As an anchor of stability in the sub-continent and with an economy that can prove to be a growth engine for the region, India has a responsibility and an opportunity to play a significant role in taking its neighbours (at least the ones interested in partaking in India's growth story) along in the journey of development and stability. The Neighbourhood Studies Programme will seek to maximise the convergences of interests in India's neighbourhood and reduce the dissonance in the divergences that afflict bilateral relationships. With connectivity becoming a critical tool in the development story of countries, the programme will explore and discuss the potential of new projects that interlink the region more closely and seamlessly. The security aspect will remain an important focus of the programme to study not just the strategic challenges but also the emerging non-conventional and asymmetric threats that impact the stability and security of the region in general and the countries in particular.

It also focused on India's engagement with the Taliban and the need for the international community to rethink its approach to the threats emanating from Afghanistan.





The historical ties between India and the Gulf egion are evolving beyond traditional economic interests, influenced by geopolitical developments and the impact of the pandemic. The crisis has spurred digital transformation and supply chain reconfiguration at an unprecedented pace, leading to the reimagining of partnerships and enhanced cooperation. The Gulf Cooperation Council (GCC) and India are reenergising their historical connections, creating new opportunities for mutual benefit and global cooperation. This backdrop sets the stage for the 2022 Arabian Sea Dialogue, where nearly 250 policymakers, business leaders, experts, and youth discussed a blueprint for an 'Arabian Sea Community,' aimed at revitalising the relationship and potential between India and the Gulf countries united by their shared connection, the Arabian Sea.

CyFy 2022



The Observer Research Foundation hosted the twelfth edition of CyFy: The Conference on Technology, Security and Society in New Delhi, India from 26-28 October 2022. This forum brought together 160 stakeholders from industry, government, SMEs, civil society, and academia from 38 countries to discuss and exchange ideas and highlight future trends. This year's conversations were designed around the theme: Conform or #Cancel: The stark binary of our digital future.

Raisina Forum for Future of Diplomacy 2022

Launched in 2022, the Raisina Forum is an annual 10-day policy workshop, which brings together 35-40 young diplomats from across the world. It seeks to foster the skills required to lead in a rapidly changing world and focuses on health, cyber governance, climate change and energy, new political geographies, instruments of development cooperation, and emerging models of multilateralism.

The objective of the Raisina Forum is to build a network of diplomats engaged with political and economic developments with the capacity to analyse emerging and complex global issues with an eye to their interlinkages across nations and regions, and with a focus on finding solutions in the Indo-Pacific and with partner countries and organisations that will influence the region and its journey. The inaugural edition of the Forum was focused on the theme "Serving Planet, People, and Prosperity" and took place from 10-20 October at the Taj Palace Hotel, Delhi. The cohort comprised 35 young diplomats from 30 countries.





Each TF has two ORF faculty assigned as coordinators in addition to a Publication track and a Social Media track of work.The Think20 has done 64 in-person events around the world as part of its work. ORF as the T20 Secretariat has been anchoring the programme formulation and dissemination through official Think20 Social Media handles.

The Secretariat also instituted and organised the Call for Abstracts for formal T20 Policy Briefs. An overwhelming 1,415 abstracts were received. After a rigorous short listing and review process, 313 policy briefs were published.

The Secretariat has also been leading the finalisation of Task Force wise statements and the Think20 Communique which was formally handed over to the G20 leaders at the Think20 Summit on 1-2 August 2023.






