AS THE WAR IN UKRAINE CONTINUES to fester in the heart of Europe, the year 2024 is ending with the world in ever greater torment, hurting with the pain of a fresh conflict reignited in the Middle East. Both conflicts are now emblematic of renewed great- and not-so-great-power rivalries that hold the warring sides hostage yet again to the absolutism of their chosen pole positions.

But bipolarity is a disorder that must be treated. It is an anachronism in a world well past the age of rivalries of the Cold War kind, led by two dominant superpowers. The world today is no longer just multipolar but has also become multi-stakeholder. It encompasses a web of connections and interconnections between not just nations but institutions, corporations, civil society communities, and influencers—a web so intricate that it is impossible to decipher where one nation's interest ends and another's begins.

What we are left with today is no balance of power but rather an unbalance, where no single entity has the will nor the power to emerge dominant. A world of alliances and coalitions to help each navigate the here and now. We struggle to diversify global value chains amidst the shifting sands of economic clout and technological prowess.

The divide between the North and South has become ever more pronounced. It is no longer a mere economic divide but has become a discursive divide where each questions the other's priorities, proprieties, and values. And in the midst of this constant questioning, the Global South today is finding new voices. These voices may be strident at times but are emerging stronger with each passing day.

Inevitably, within this melee, India's 1.4 billion people too, are finding their voices—voices that speak not just for themselves but for others of the Global South.

Can India in these conflicted times become the bridge between these divided worlds? Can it emerge as the wellspring for a truly multipolar and collaborative approach that can help the world abandon confrontation and return yet again to cooperation?

It showed the way during its G20 Presidency through its commitment to fostering global dialogue and consensus. The principle of *Vasudhaiva Kutumbakam*—“The world is one family”—guided the Global South as it brought its voice to the forefront of global discourse. ORF, as part of its T20 stewardship, played its part.

Building on the momentum of India’s G20 presidency, ORF further deepened its engagement with Africa, a region critical to the evolving world order. Our annual Kigali Global Dialogue continued to provide a platform for meaningful exchanges, and we took a significant step forward by launching the Cape Town Conversations in South Africa.

The Raisina Dialogue, flagging the theme, “Chaturanga: Conflict, Contest, Cooperate, Create”, set the stage for critical discussions between government leaders, policymakers, and thought movers from across the world. Adding to the success of our Raisina iterations in Washington, Sydney, and Berlin, we expanded our reach with the launch of Raisina @ Tokyo in March.

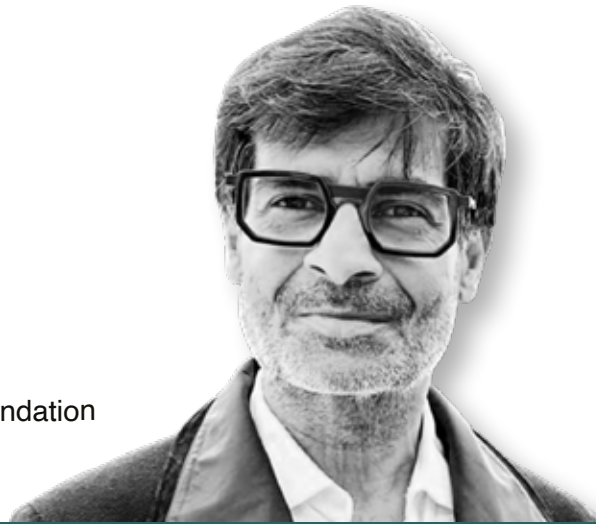
The Indian G20 presidency also steered the conversation towards just transitions—a theme that ORF has explored with renewed vigour. In 2023, we launched the Energy Transition Dialogue, a platform designed to critically assess the prevailing narratives surrounding inclusive energy transitions. The dialogue was followed by yet another significant event, From G20 to COP28: Energy, Climate, and Growth, which focused on elevating the voices of the Global South within the global climate policy discourse.

Our centres in Mumbai and Kolkata, by engaging with state governments, local bodies, and grassroots organisations, mirrored these efforts at the regional level. Notable events included the Kolkata Dialogue; Data for Development: Actions, Experiences, Lessons; Inclusive Futures, Impactful Pathways; and Urban Frontiers: Pathways to Resilient, Inclusive, and Equitable Cities.

ORF SPARK returned in 2024 to reach out to both urban and rural youth, eliciting policy conversations in schools, colleges, and universities. The results were captured in the publication, *Hope in the Horizon: India’s Youth and Global Futures*—a collection of essays offering fresh insights and perspectives into some of the most crucial issues facing the world today.

Through its publications, ORF continued to stimulate expert discussions, producing over 2,000 short-form articles and 200 long-form policy research papers over the year. Among these, two seminal volumes stand out. The first, a collaboration with Reliance Foundation, *Ideas, Innovation, Implementation: India's Journey Towards the SDGs*, showcases 17 lighthouse case studies from India, each addressing a specific Sustainable Development Goal (SDG). These case studies offer potential pathways for transformation. The second, produced in association with PwC and titled, *The India Opportunity: Developing Resilient Electronics Supply Chains*, underscores the importance of building resilient supply chains for India to integrate seamlessly into global production networks.

As we look to the future, ORF remains resolute in its mission to be a catalyst for change in a world that is increasingly being defined by complexity. We are committed to fostering conversations that matter, building partnerships that drive progress, and advancing research that illuminates and inspires. The road ahead may be fraught with challenges, but it is also rich with opportunities. I am confident that, with the continued dedication of our colleagues and the unwavering support of our partners, ORF will continue to make meaningful contributions to the global discourse and help create a brighter world.

IF WE HAD THOUGHT that 2023 was tumultuous enough, 2024 is proving to be just as tempestuous, giving us extraordinary events that are altering the visage of the global order. A number of seminal elections have been conducted in many countries over the year, and at the time of writing this note, several more are scheduled to be held. India cast its vote in a keenly contested general election between April and June that led to a historic third term for the ruling party; the UK ushered in change as a Labour government took the helm after over a decade of the Conservatives; and the US could see its first female president in Kamala Harris before the year ends. Wars continued to rage across geographies, and in different parts of the world, democracies were undermined due to internal factors and external machinations. It is an unstable time for global security, and as disruptions brew and conflicts erupt, plural societies need to work exponentially harder to defend the gains since the big wars in Europe last century.

The year has already lent itself to much history-making. The Earth experienced its hottest day on record; “artificial intelligence” entered our everyday lives with aplomb, stirring both excitement and anxiety; and conflicts continued to be the preferred mode of dispute resolution, relegating dialogue to a distant memory.

How does a think tank, even one as experienced as ORF, make itself relevant at such a juncture? In the past year, we counted the ways.

In April, ORF co-hosted the Climate Action Champions Network in Dubai, United Arab Emirates, as torrential rains flooded the city. One hundred individuals from India, Bangladesh, Nepal, Sri Lanka, and Bhutan gathered to discuss and explore solutions to the disproportionate impacts of climate change on countries of the Global South.

It was also this year that we launched ORF Middle East, our new overseas affiliate, based in Dubai. ORF Middle East aims to discover policy ideas in and for a region both exciting and complex. Cities and countries located here are poised to help shape India's future and, in turn, stands to become the largest beneficiary of India's rise.

Indeed, 2024 has been a watershed year for countries of the Global South, with more of them taking the centre stage in global conversations and becoming increasingly unabashed in flagging their needs and magnifying their aspirations. In February, ORF hosted its annual ministerial discussion on the sidelines of the Munich Security Conference, tackling the new role of the Global South. The panel, titled "Vishwa Mitra: Bridging Divides", featured Dr. S. Jaishankar, India's External Affairs Minister; Prince Faisal bin Farhad Al Saud, Saudi Arabia's Minister of Foreign Affairs; Mr. Stephen Harper, Canada's Former Prime Minister; Ms. Margrethe Vestager, Executive Vice President of the European Commission for a Europe Fit for the Digital Age; and Dr. Meghan O'Sullivan, Director, Belfer Center for Science and International Affairs, Harvard Kennedy School.

ORF incubated a few other dialogues this year, spotlighting the ambitions of the emerging powers and the developing world. These included the Energy Transition Dialogues in New Delhi, which conceived solutions for a people-positive energy transition in the Global South. We also hosted our annual event in New York during the United Nations high-level week, in partnership with UN in India, the Permanent Mission of India in New York, and Reliance Foundation. Our ministerial session, "South Rising: Partnerships, Institutions and Ideas", discussed the role of India and the Global South in driving development in the 21st century. It featured Dr. S. Jaishankar, India's External Affairs Minister; Kamina Johnson Smith, Jamaica's Minister of Foreign Affairs and Foreign Trade; Mr. João Gomes Cravinho, Portugal's Minister of Foreign Affairs; and Hugh Hilton Todd, Guyana's Minister of Foreign Affairs and International Cooperation.

In 2023, as the Secretariat of the T20 during India's G20 presidency, ORF managed one of the largest think-tank coordination exercises in the grouping's history: 131 international and national experts participated in seven task forces, with nearly half of all members being women; 64 convenings were held across 16 Indian cities and six overseas locations, of which four were in the Global South (i.e., Rwanda, Indonesia, the United Arab Emirates, and South Africa); and in September, the Think20 Summit 2023 took place in Mysuru, bringing together 210 experts from 35 countries and 110 institutions across the world.

In addition to ORF's own publications, the Think20 Secretariat oversaw the writing and release of over 300 policy briefs and other publications. No less than 1,000 authors from 75 countries across the globe contributed to this feat, with 43 percent of them being women. We put together seven task force statements and the final T20 Communiqué, and presented these to the sherpa track in the run-up to the final Leaders' Summit, resulting in our own recommendations making it to the final G20 Declaration.

We hosted the formal handover of the Think20 to our successors in Brazil at our new flagship conference—the Cape Town Conversation—establishing a platform for conversations around G20 and the Global South.

This year, during Brazil's G20 presidency, ORF continued its engagement with the Think20, ensuring Indian representation in five of the six task forces. Our scholars are serving as chairs and co-chairs on three of the task forces. ORF also has a representative in Brazil's International Advisory Council Secretariat and has made efforts to ensure that the work done by India is being carried forward by the successive presidency.

The Raisina Dialogue, our flagship event which has now become a fixture on the calendars of many leaders across the globe, started 2024 with a flourish. Inaugurated by Greek Prime Minister H.E. Kyriakos Mitsotakis and Indian Prime Minister Shri Narendra Modi, it saw the participation of 20 foreign ministers; 24 Cabinet ministers; five former heads of states; nine heads of military commands; and 37 heads of think tanks from more than 25 countries. With over 100 sessions and nine associated events, Raisina Dialogue 2024 hosted over 3,600 participants from 120 countries. During the Dialogue, we published *Raisina Chronicles: India's Global Public Square*, a volume I had the pleasure of co-editing with Dr S. Jaishankar, to commemorate a decade of Raisina. It makes for a precious time capsule, containing essays and speeches from past participants, to capture the evolution of the Raisina Dialogue over the years.

ORF will continue to expand Raisina's scope and grow more branches across the globe in the hope of creating a truly global public square. We added a new global arena in March this year with the Raisina Roundtable @ Tokyo, where delegates discussed the Quad and the developments in the Indo-Pacific region.

Our Mumbai and Kolkata offices continued to do inventive work on numerous fronts. One of them is ORF Spark, our signature youth outreach programme that brings policy conversations across schools, colleges, universities, and other engagement spaces. It has so far reached over 17,000 young people across nearly 50 colleges and schools in the cities of Mumbai, Pune, Nagpur, and Vadodara.

It is the same recognition of the power of India's youth that was evident in our publication, *The ORF Foreign Policy Survey 2023: Young India and the Multilateral World Order*. The report highlighted some of the youth's most crucial concerns about the country's foreign policy.

ORF Kolkata has emerged as the foundation's data-centred policy research hub. Its publications covered vast policy domains and enriched key debates through their incisive data driven approach to problem solving. Building on our 5x series (our past ones include Maharashtra and Gujarat), our scholars in Kolkata put together the publication *Leap to the Himalayas: A 10-point Agenda for a 5x Nepal*, which presents a concise 10-point strategy for Nepal's transformation into a prosperous, resilient and globally connected nation. In *India Employment Outlook 2030: Navigating Sectoral Trends and Competencies*, the authors presented invaluable insights into the nation's evolving workforce, and identified emerging sectors and skills crucial for India's future growth.

Looking ahead, I am incredibly excited about some upcoming initiatives. One is in Armenia—the fastest-growing economy in Eastern Europe and Central Asia and an upcoming giant in the technology domain. This month, we will launch the Yerevan Dialogue that will discuss crucial issues like connectivity, climate change, economic instability, and the ethics of technological innovation.

Then there is Raisina Middle East in Abu Dhabi. This newest member of the Raisina family will be the venue to discuss global trade, investments, resilient and sustainable infrastructure, technology and innovation and fair and equitable energy transitions.

I am also thrilled to announce the launch of Sagarmathan: The Great Oceans Dialogue, which we will host in partnership with India's Ministry of Ports, Shipping and Waterways in the business capital of India, Mumbai. Designed as an annual dialogue, Sagarmathan will serve as a global platform for conversations on the blue economy, maritime logistics, ports, shipping and waterways sectors, critical minerals, diversified supply chains, the global maritime economy, and training and labour standards.

Even as we engage the future, I am reminded of ORF's foundational ethic of collaboration—of recognising that no country is truly an island and it is only in working together that we can attempt to solve the most urgent problems we confront. ORF has made it its mission to build global communities and shall continue to be led by this conviction.

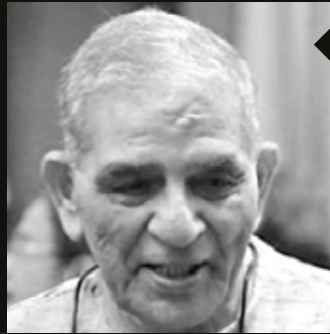

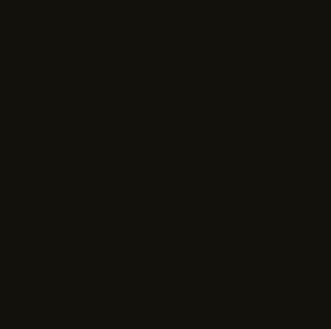

Additionally, we have provided a nuanced understanding of the global climate action discourse, highlighting the perspectives and challenges of developing nations. Our aim has been to highlight the necessity for global partnerships to adapt and ensure equitable and inclusive transitions in these regions.

Vision For the Future

Moving forward, the Centre for Economy and Growth is committed to furthering its efforts in understanding the interconnections between effective climate action and inclusive growth. Specifically, we will look to create roadmaps for ensuring a just and inclusive transition by focusing on means to accelerate high potential sectors of the energy transition including green hydrogen, energy storage, and decentralised renewable energy. We will also look to create an ecosystem to accelerate increased international private investment for climate action in India. Increasingly we will also look to mainstream the need to prioritise climate adaptation as a means to achieve the SDGs. Our ultimate goal is to shed light on the voices and regions that have thus far been marginalised in global policy discussions, thus, amplifying their significance.

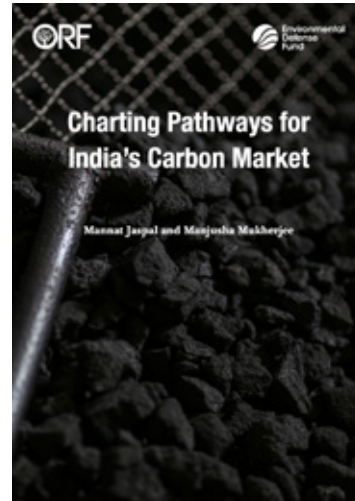

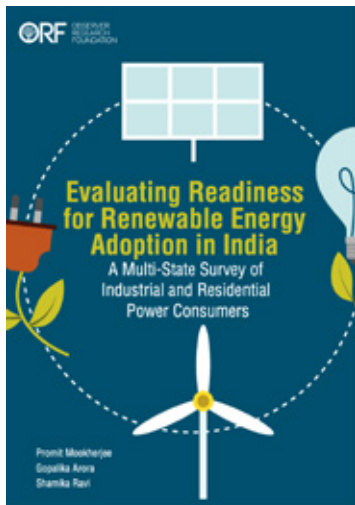

MISSION STATEMENT

With its initial mandate to delineate economic diplomacy in a changing world, the Centre for New Economic Diplomacy (CNED) has attempted to craft a new approach towards post-pandemic recovery and resilience. On the other hand, there is an increasing acknowledgement among the global community that the business-as-usual models of development are proving counterproductive, and there is a need to carve out new development pathways for the global south. To do so, the Centre has attempted to build transnational partnerships and strengthen multi-stakeholder responses to the development challenges confronting the international community. It has primarily focused on geographies like South Asia, ASEAN, BIMSTEC, and Africa where development challenges emerge in various forms: either in the garb of “development deficit” or in the forms of environmental degradation and social costs of growth. International trade, connectivity, macroeconomics, labour markets, development finance, technology, climate change, health, food and nutrition, etc are some of the major domains of intervention of the Centre. Treating gender equality as a critical normative developmental concern with its intersectionality across other SDGs, CNED has built gender as a cross-cutting driver across its various verticals.

A QUICK VIEW OF THE PAST

In 2023, a large component of CNED’s efforts went into handling the operational and research management of Think20, the think-tank engagement group under India’s G20 Presidency. CNED scholars and the extended research community produced 81 long-form papers (combining ORF and external peer-reviewed publications) and 247 short-form pieces under the various domains of CNED’s research interventions and organized more than 50 digital discussions, webinars and physical workshops and

panels. These also include edited volumes and policy briefs published under various task forces of the Think20. CNED scholars have worked on macroeconomic problems of the South Asian economies, models of inclusive growth in the BRICS, development partnerships for promoting SDGs, water governance including water pricing and national water policy for India, the intersectionality of climate change and SDGs, Indo-Pacific strategies of India and South Korea, AI governance in India, etc. CNED's report entailing recommendations for Nepal charting the path towards five times its present GDP has been an important research highlight of 2023-24. Other important research outputs include projecting the size of the Unified Payment Interface (UPI) market in India as the country traverses its path to attain a US\$5 trillion economy; an evaluation of the G20 countries in the context of their pandemic response by using the 'Sustainomics' framework; and the Capetown Chronicles (the publication outcome of the Capetown Conversation organized in association with the Thabo Mbeki Foundation, during November 2023) that delves into Africa's persisting development concerns amidst the lingering effects of the pandemic and the debt crisis. As evident in 2023-24, significant forums like Capetown Conversation and Think20 engagements aside, CNED's events and publications have broadened its development network and community engagement. This was made possible by engaging with both traditional and non-traditional stakeholders on key issues of Sustainable Development Goals (SDGs). The partners with whom CNED scholars worked include IFPRI, UNFPA, Reliance Foundation, Coca-Cola, DASRA, BMGF, AFD and PWC, to name a few.

VISION FOR THE FUTURE

At the heart of CNED's vision lies the creation of resilient economic systems through a holistic development approach. As we navigate the post-pandemic landscape, the Centre's future endeavours will be shaped by focusing on economic resilience, green recovery, and advancing the Sustainable Development Goals (SDGs). In 2023, the mid-year assessment of the SDGs suggests a scanty achievement of the avowed goals that are supposed to be achieved by 2030. Therefore, the question that looms large is: what after 2030? This question will drive CNED's endeavours. While the Centre remains dedicated to its established areas of expertise, it is also poised to adapt to emerging needs. On the other hand, geoeconomic developments during the G20 Leaders' Summit (e.g., India-Middle East- Europe Economic Corridor or IMEC) that can shape the global geopolitical narratives and development trajectories will need attention. Additionally, the Centre will delve into critical analyses of Regional and Free Trade Agreements, natural capital assessments and environmental market developments in the global south, new development cooperation models, reforming the

international financial architecture, digital financial inclusion, technology and society, gender and development in the global south including women's leadership climate change, food and nutritional security, global health, new institutional structures for global labour market, development and climate finance, etc. The focus will largely be on Africa and South Asia, both of which are climatically and economically vulnerable. The Centre also plans to conduct country-specific studies that will help developing and underdeveloped countries move to a higher growth trajectory. On the other side, CNED will also take up important issues and concerns relevant to India's aspiration of Viksit Bharat 2047—the ambitious vision to catapult the nation into a developed economy—and aspires to inform the policymakers, opinion-makers, and civil society and the citizenry about the steps to achieve the same.

The roundtable discussion emphasised the critical issue of youth unemployment and the growing gap between degrees and job opportunities, focusing on the shortage of skilled human

power rather than financial concerns. The conversation also highlighted the gendered nature of the care economy, where women disproportionately bear caregiving responsibilities, calling for strategies to promote inclusive growth. Additionally, the global impact of India's policy decisions was discussed, stressing the need to bridge research and policy gaps for more informed and effective outcomes.

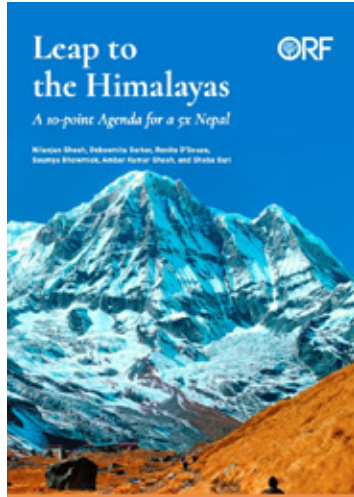

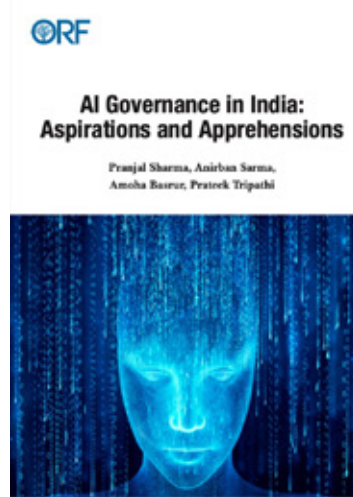

MISSION STATEMENT

Critical and emerging technologies are at the centre of contemporary international politics, determining the contours of conflict, contestation, and cooperation. As the far-reaching implications of these technologies intersect politics, economics, and society, nations are aggressively pursuing strategies to gain dominance and influence geopolitical landscapes. The rise of minilateral alliances underscores the search for tech-based partnerships among like-minded countries. Amidst this intense competition for technological supremacy, a critical gap in global governance has emerged, leaving a regulatory void.

India, as a major digital power in the Indo-Pacific and as a bridge between the Global North and Global South, has a pivotal role in shaping the trajectory of tech cooperation and regulation, even as it seeks to harness critical and emerging technologies. The Centre for Security, Strategy and Technology (CSST) at Observer Research Foundation (ORF) seeks to advance an Indian perspective on the evolving geotech landscape. Towards this, it regularly carries out robust, multi-disciplinary research and scholarship in critical and emerging technologies. Collaborating with governments, academia, think tanks, and the policy community, the CSST aims to foster multi-stakeholder discussions on harnessing technology for a positive future.

A QUICK VIEW OF THE PAST

Over the past year, CSST continued its focus on critical and emerging technologies by conducting research and convening workshops, webinars and panel discussions around them. These covered themes such as the impact of emerging technologies on the evolution of warfare, state of global and regional cybersecurity cooperation,

emerging US-China tech competition and Artificial Intelligence and data protection regulations. In addition, the centre played a critical role in shaping Quad's technology cooperation through its participation in the Quad Tech Network and Quadrilateral Critical and Emerging Technology Forum. Besides, CSST faculty members actively engaged with their counterparts at a variety of international and national forums, including closed-door and public gatherings, to discuss the geopolitical dimensions of technology.

VISION FOR THE FUTURE

In the upcoming year, the centre will sharpen its focus on emerging technologies by amplifying research on three dimensions: global competition, quest for governance, and impact on India. Besides, in line with its commitment to expand multi-stakeholder engagement, CSST will work with partner institutions to study previously unexplored domains such as cyber resilience, genetic engineering, semiconductors and quantum encryption. In addition, the centre aims to engage with new voices and partners to advance the stated vision of multi-disciplinary research.

Strategic Studies Programme

MISSION STATEMENT

ORF's Strategic Studies Programme seeks to shape India's foreign policy and national security choices by deepening understanding and identifying policy interventions on contemporary Indian and global debates. The programme offers original analysis—a mix of theoretical, historical, and practical perspectives—through extensive academic research, interdisciplinary studies, data-driven analysis, and engagement with experts and policymakers. The programme's outreach activities, in the form of seminars and roundtables as well as collaborations with ORF's growing network of worldwide partners, serve to enhance and frame growing public debate, domestically and around the world, on India's power and its purpose.

A QUICK VIEW OF THE PAST

In a world clouded with geoeconomic uncertainty and the sharpening of geopolitical contestation, the researchers of the Strategic Studies Programme continued to engage with a range of national and global stakeholders on key themes: the state of global (dis)order; institutional infirmities and normative shifts; increasing great power contestation; emergence of middle powers; evolving strategic contours in the Indo-Pacific, Eurasia, and Africa; maritime challenges and opportunities in and around South Asia; trends in India's neighbourhood; Indian foreign and national security policies; and the changing nature of warfare. The programme made important interventions in all the above mentioned areas by producing academic research, policy studies as well as via extensive outreach engagements.

VISION FOR THE FUTURE

India is, today, unmistakably global as it anchors itself as a regional and global stakeholder. A fragmented world and the advent of new challenges call for a contemporary understanding of power transitions, key geographies, global institutions, and security threats, critical to inform choices for an evolving and emergent India.

In 2024-25, the Strategic Studies Programme will continue to track regional and global developments and trends that implicate India's capacities and options, now and in the future.

Some key areas of focus include the following:

A continuing global power transition mandates greater scrutiny of the US-China rivalry and its impact on Indian pursuit of its interests. Rediscovered geographies will likewise continue to be a key and expanding focus area, whether the broad Indo-Pacific and Eurasian spaces, or sub-regions in India's immediate and extended neighbourhood.

The programme will also delve into evolving traditional and non-traditional threats to India's national security amidst the changing nature of competition and warfare.

Our future research agenda aims to be forward-looking. India's role and responsibilities in the world will continue to derive from an understanding of the changes in the traditional global architecture as well as its own growing capacities.

Youth unemployment is at an all-time high, presenting serious worries for the regime, while the United States and its partners are working to deny technology critical to China's development. This event—part of the China Chronicles series that explores the rise of China as a global player along multiple axes and its implications to provoke a more nuanced debate in India—featured perspectives from experts on the trajectory of the world's second-largest economy.

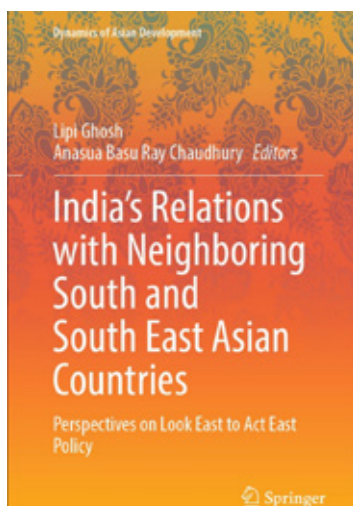




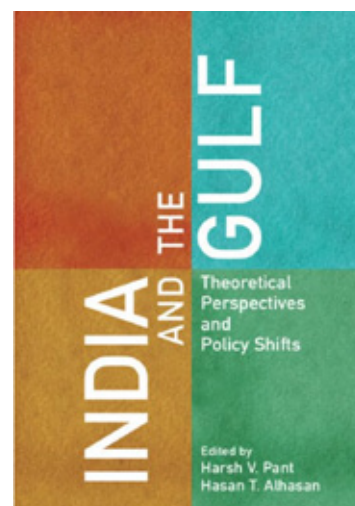

Neighbourhood Studies

MISSION STATEMENT

The Neighbourhood Studies Initiative of the Strategic Studies Programme aims to promote research on the key pressing issues of India's Neighbourhood. As the world order transits from the West to the East and pivots around the Indo-Pacific region, India and its neighbourhood—entailing the regions of South Asia and the Indian Ocean—is gaining geostrategic importance. At the same time, it is a region in turmoil, which impacts India's security and stability, especially in India's periphery. India, which has traditionally maintained a strong presence among its neighbours for development, security, and strategic goals, is seeing an assertive and aggressive China increase its influence among its neighbours. This evolving competition has also incentivised other powers to assert themselves in the region, placing India and its neighbourhood in a geopolitical spotlight and calling upon a thorough understanding of the region.

A QUICK VIEW OF THE PAST

The Neighbourhood Studies programme has been analysing developments in the region and their implications for India through commentaries and long-forms for ORF and in external publications. The scholars associated with the programme were very active in the print, electronic, and digital media offering their comments and analysis, raising the profile of ORF as well as taking forward the public discourse on the region. The team has also been delivering lectures and talks at premier institutions like Foreign Service Academy, various war colleges and other symposiums. In addition to organising a monthly discussion telescoped on a specific issue/country of the region, the scholars have interacted with visiting delegations and diplomats, acquainting them with India's stand on developments in the region.

VISION FOR THE FUTURE

The political and security challenges have multiplied in the region. The violent overthrow of the government in Bangladesh has added to the complexities in India's strategic environment. The situation in Myanmar is spiraling out of control. Pakistan remains hostile and unstable. Tensions with India are likely to increase as the problems for the Pakistani regime multiply. The tidal wave of terrorism in Pakistan coupled with political instability and near economic collapse means India could have a huge crisis on its Western borders at a time when its eastern and northern borders (China) are also disturbed. Although the new government in Maldives has tempered its stand on India, the situation remains fraught. Afghanistan continues to present challenges, and despite short-term accommodation of India's interests, questions remain about the kind of policy India needs to pursue with that country. Amidst the flux in India's neighbourhood, the Neighbourhood Studies team will strive to highlight emerging trends and developments, analyse them to inform and suggest policy alternatives that protect and advance India's interests.

The Neighbourhood Scope Prachanda Paradigm: Revisiting India-Nepal Ris(h)ta



Nepalese PM Pushpa Kumar Dahal's recent visit to India triggered immense interest in the trajectory of India-Nepal relations. Some have called the visit a mark of "new history," others have termed it an "old wine in a new bottle". How can New Delhi

and Kathmandu address their major irritants without giving in to their domestic politics and pressure? As India and Nepal undergo significant politico-economic and systemic transformations, how should both countries interact with each other? How can India and Nepal leverage the ongoing geopolitical jostling to further their mutually beneficial relationship?



December 10-20, 2023 Nepal's Young Leaders' Delegation

On December 10-20, 2023, the Observer Research Foundation hosted the first edition of the interaction programme with Young Leaders from Nepal. The programme seeks to provide a platform for young Nepali leaders to gain insights into various undergoing transformations, and network and familiarise themselves with Indian policymaking circles and the civil society. This will deepen the cooperation between the peoples and government of the two countries and familiarise the delegates with India's economy, society, and polity.



December 14, 2023 Neighbourhood Scope The Durand Churn: Reassessing Afghanistan- Pakistan Relations



Tensions are once again flaring up on both sides of the Durand Line. Pakistan's decision to evict undocumented immigrants from the country and the resultant surge in militant attacks inside Islamabad has aggravated already fraught ties between Afghanistan and Pakistan. The Taliban has also hardened its position by criticising the decision as 'unjust' and 'un-Islamic.' More than two years since the group returned to power in Afghanistan, Pakistan's expectations of reaping the dividends of an Islamic Emirate in its neighbourhood have come to naught with the current caretaker Prime Minister declaring how 'peace' in Afghanistan has become a nightmare for Pakistan.



January 30, 2024

Neighbourhood Scope | Bangladesh: A Post-Election Assessment



Since being re-elected to power in 2009, Prime Minister Sheikh Hasina has promoted political stability, cracked down on extremists, and ushered in an era of economic growth and development in Bangladesh. Her fourth consecutive win in January 2024 is also largely expected to lead the country on a similar trajectory of stability and growth. However, the next five years are not free of challenges. The opposition Bangladesh National Party (BNP) is provoking the masses to join street protests, the West has continued to criticise Bangladesh's democracy despite accepting the election results, and conflicts across the world have begun to impact the economy. Most importantly, Bangladesh will have to continue to balance between India, China, and other major powers as the Bay of Bengal region grows in prominence.

Bhutan and India enjoy a time-tested relationship “based on trust, goodwill, and mutual understanding.” However, Bhutan, a tiny landlocked nation between India and China, is at a crossroads. It is attempting to end its border disputes with its assertive and aggressive northern neighbour, China, while being sensitive to Indian security interests and concerns. At home, the country is confronting an economic crisis while its working population is migrating elsewhere. With multiple crises at the forefront, there is an increasing call within Bhutan to promote domestic reforms and end the border dispute with China while diversifying its economy, bilateral ties, and development partnerships.

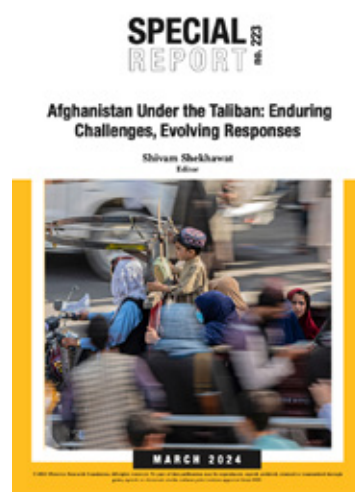

Raisina Forum for Future of Diplomacy 2023

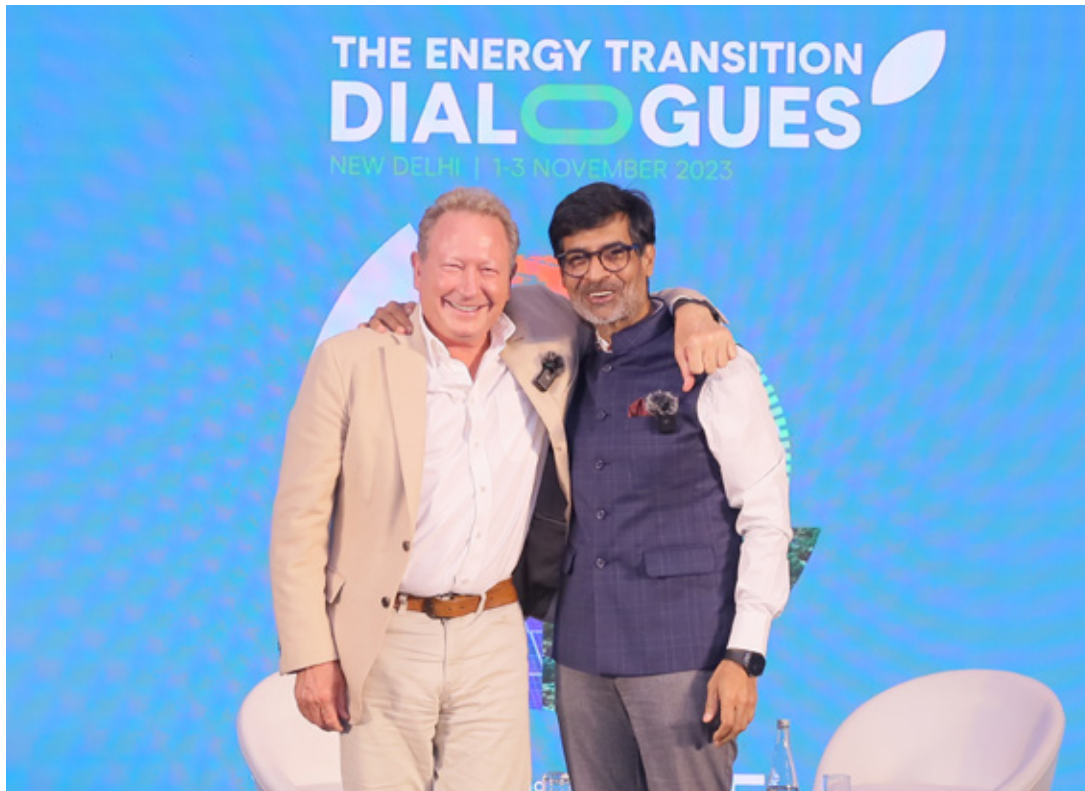

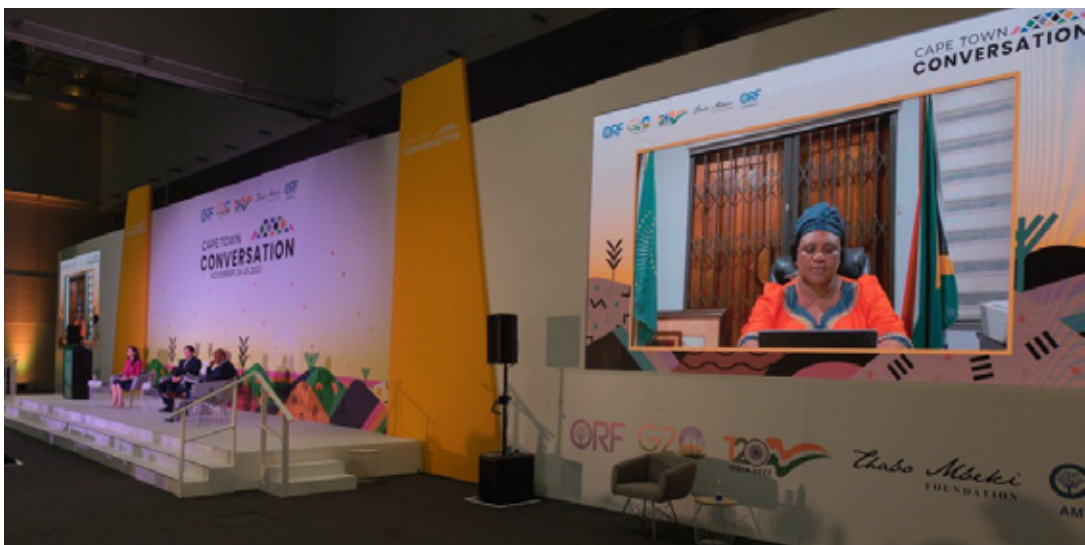

RAISINA DIALOGUE 2024



The Raisina Dialogue continues to be India’s premier platform for global discourse on geopolitics and geoeconomics. As the world grapples with complex challenges, the 2024 edition of the Dialogue, themed “Chaturanga: Conflict | Contest | Cooperate | Create,” brought together a diverse array of leaders, policymakers, and thinkers from across the globe to deliberate on the most pressing issues facing the international community. Hosted by the Observer Research Foundation in partnership with the Ministry of External Affairs, Government of India, this year’s conference drew a remarkable attendance of 3,300 participants, including heads of state, cabinet ministers, local government officials, and thought leaders from the private sector, media, and academia. Over the course of 118 sessions, including an Inaugural Session, Valedictory Address, Ministerial Addresses, and various other discussions, participants engaged in deep dives into critical global issues.

The Dialogue featured an impressive lineup of speakers, such as Stephen Harper, Former Prime Minister of Canada; S. Jaishankar, Minister of External Affairs, India; and Børge Brende, President of the World Economic Forum. Demonstrating a strong commitment to gender parity, the event saw 1,184 women among its 3,300 attendees and 126 women among its 293 speakers, reflecting the Dialogue’s inclusive approach to global discourse. The Raisina Dialogue 2024 not only reinforced its status as a leading global conference but also emphasized the need for collaborative efforts to navigate the complexities of the modern world, contributing meaningfully to shaping the future of international relations and global governance.

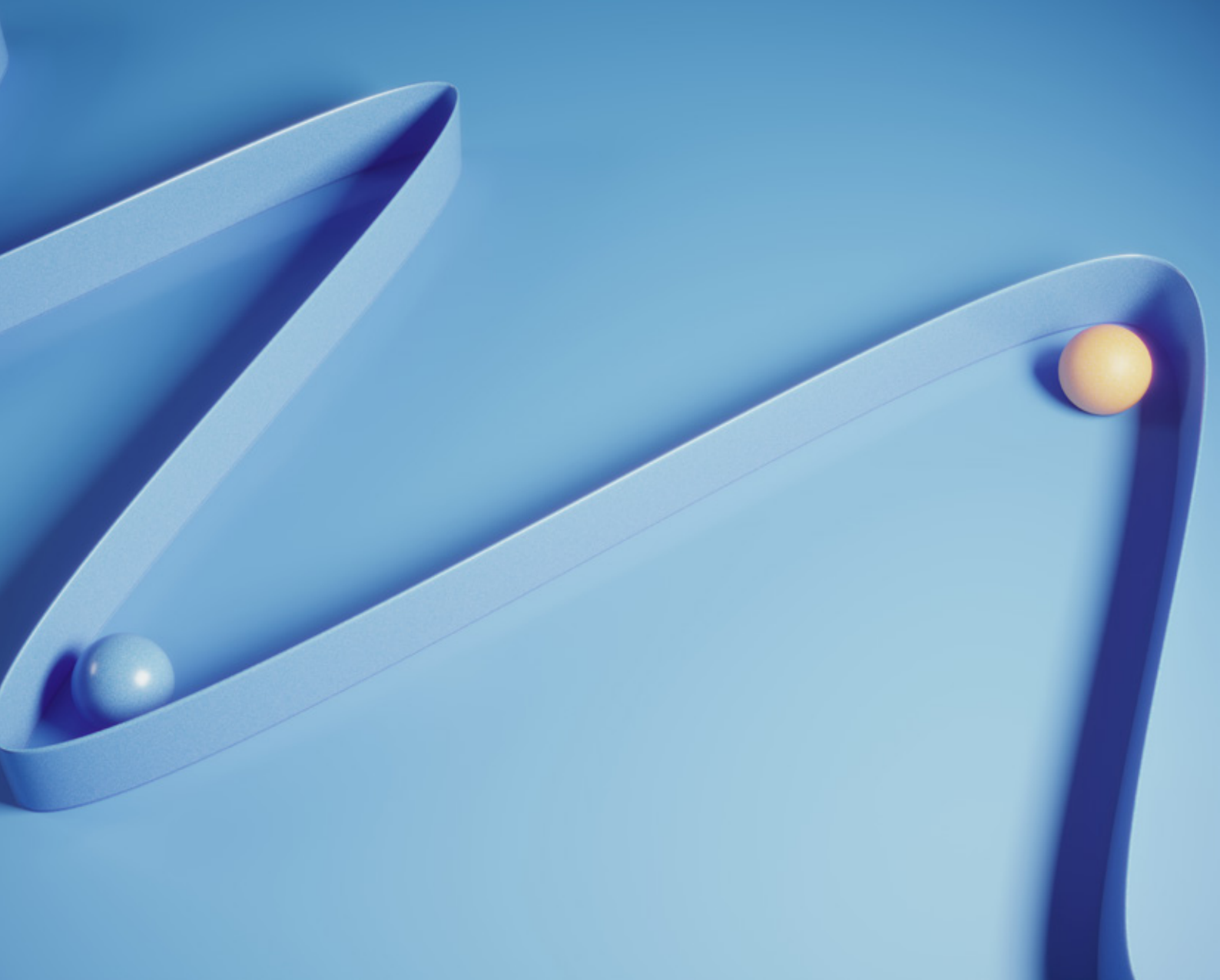

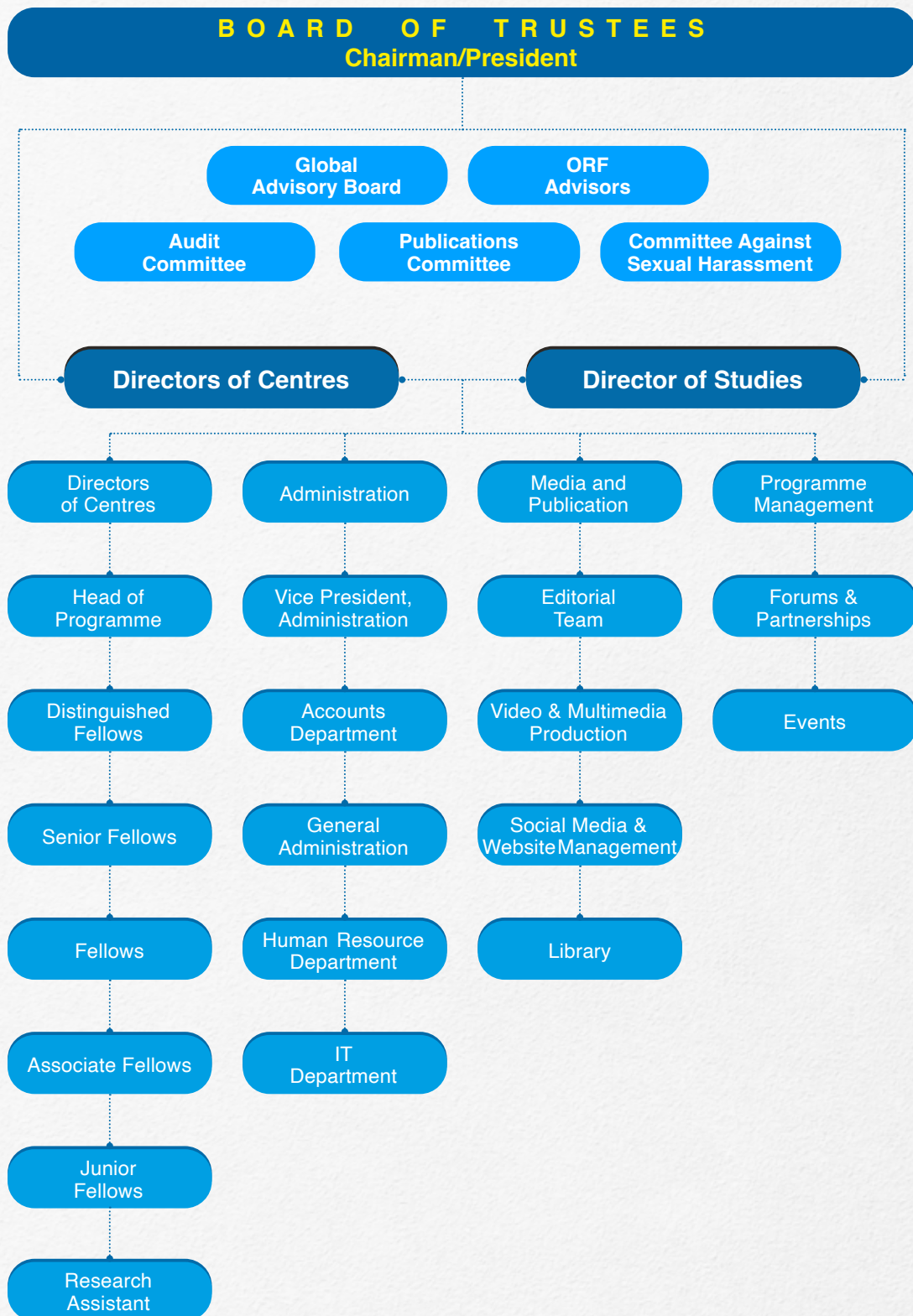
